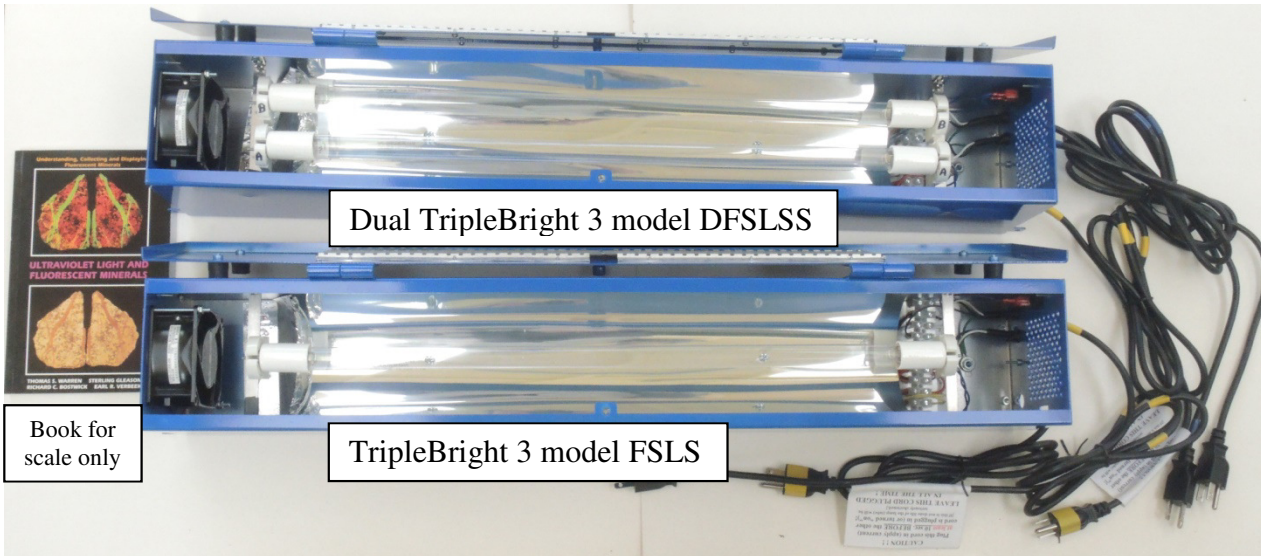


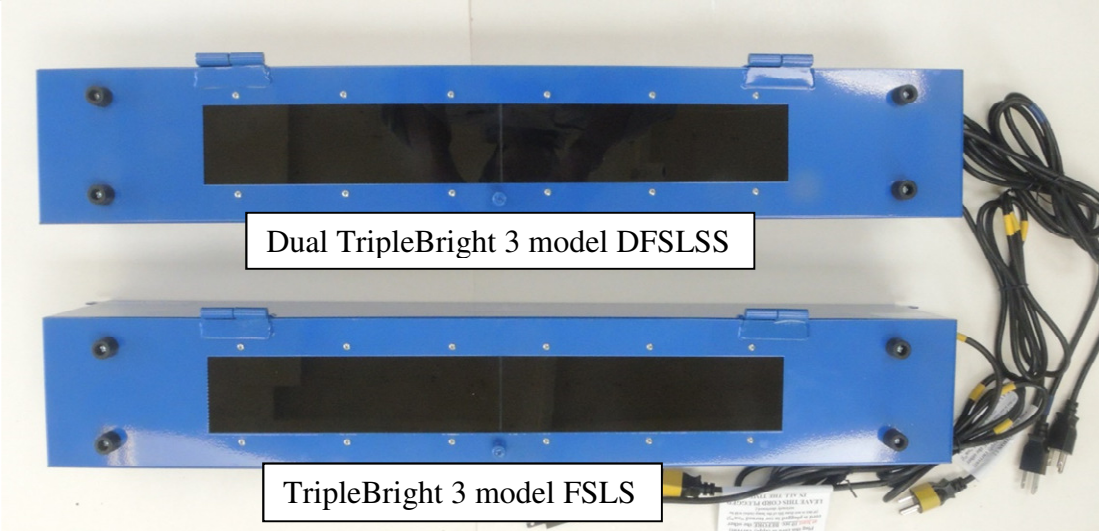
UV SYSTEMS, Inc.

1. UV SYSTEMS, Inc. will provide, at a substantial discount, up to 30 Short Wave (SW) display ultraviolet lights for use in the fluorescent mineral displays at the 2021 Tucson Gem & Mineral Society (TGMS) show. The 2021 TGMS show should be bigger and better than **Tucson '96. This offer is to enable FMS members that do not have a display light to be able to display at Tucson 2021.**
2. The UV lights will only be SW and can be the single lamp (bulb) TripleBright 3 model FSLs light or the Dual TripleBright 3 model DFSLSS with two SW lamps. The special Tucson 2021 lights will be functional equivalent to production lights except for minor cosmetic changes such as color and feet. No Long Wave lights will be available.
3. These SW UV lights will be made available on a first-come first-served basis, and no more than 30, total, will be offered at this discount. All orders must be placed by January 31, 2020.
4. The discount will be approximately seventy (**70**) percent of the 2021 list price for a SW TripleBright 3 or SW Dual TripleBright 3 UV light. A 70% discount is far below actual cost to UV SYSTEMS, Inc. For example in August 2019 a SW TripleBright 3 model FSLs list price is \$1,251.00, but the discounted price **would only be \$379**. Another example is a SW Dual TripleBright 3 model DFSLSS with a list price of \$1,560.00, with the discount that **would only be \$469**.
5. Only paid up members of the FMS that have been members since January 2020 (or before) will be eligible. Only one discounted UV light per FMS member is allowed. **These lights are only for use in the display of the member requesting the discount. Sorry, we can't allow members to transfer their lights to others during the show. They must be used in a display of the member/purchaser's own collection or the purchaser will be billed for the regular list price.**
6. FMS members that would like to order one of these UV lights must contact UV SYSTEMS, Inc. only by email or US mail, no phone orders or PM will be allowed. The following information is required when ordering; first and last name, permanent mailing address, a phone number, email address, your FMS membership number, and what model you want SW TripleBright 3 model FSLs, or SW Dual TripleBright 3 model DFSLSS. When your order is accepted a \$50.00 non-refundable* deposit will be required within 15 days. Other order requirements might be required later. Orders will be accepted 20 days after this notice appears in the UV Waves. UV SYSTEMS, Inc. will have final say as to which orders are accepted.
7. The 2021 list price for the SW TripleBright 3 model FSLs, or SW Dual TripleBright 3 model DFSLSS UV lights will be published by July 31, 2020.

8. Full payment (less the discount and deposit) must be made to UV SYSTEMS, Inc. before October 1, 2020 for any UV light purchased. Residents of the state of Arizona will be required to also pay AZ State Sales tax.

9. The specific model of UV light will be shipped to Tucson before the show setup date. No freight will be charged for shipping the lights to Tucson. The customer or a volunteer worker will assist in installing that special TripleBright 3 or Dual TripleBright 3 in your display.

10. After the TGMS show closes the customer can take possession of his or her UV light, but not before. Return shipping boxes will be available at an additional cost.

11. The terms of this contract can be modified at any time by UV SYSTEMS, Inc. providing that the customers have been given 20 days' notice beforehand.

UV SYSTEMS, Inc. is making this offer only to help the FMS attract more members to display at the TGMS show. Please respect our willingness to aid the fluorescent mineral collector community and work within our restrictions. Let's make Tucson 2021 the best display of fluorescent minerals the world has ever seen in one place!
